A. Negotiations are re-opened for Line Items 002-GI and 005-DI, FOB Destination, Ramadi Area, until Wednesday, March 10, 2004, at 9:00 A.M. (0900 hours), local time, Ft. Belvoir, Virginia, USA.

1. The following condition is added to the Solicitation Package, Page 26, concerning offerors of product from the Jordanian border for the aforementioned line items:

32. Conditional Acceptance of Contract

This contract shall not be binding until the contractor submits to the contracting officer a letter from the Jordanian government which permits the contractor to bring fuel through Jordanian territory in transit to Iraq. This letter must be received by the contracting officer by midnight, United States EST, 2 Jordanian business days after the contract is signed and must be satisfactory to the contracting officer. If the letter is timely received and satisfactory to the contracting officer, the contracting officer shall notify the contractor that contract has come into effect and finalize the award by contract modification. If the letter is not timely received and/or is not satisfactory to the contracting officer, then the contract will not be binding and will be null and void.

B. For those offerors of product from the Kuwaiti border who are non-refiners and require a letter of commitment, as outlined in the Offeror Submission Package, Page O-19, Paragraph 13, EVIDENCE OF RESPONSIBILITY, this documentation must be submitted by Wednesday, March 10, 2004, at 9:00 A.M (0900 hours), local time, Ft. Belvoir, Virginia, USA. Failure to submit a supply commitment will result in an offer being determined ineligible.
