Solicitation SP0600-03-R-0155 is hereby amended as follows:

1. Negotiations under solicitation SP0600-03-R-0155 have been re-opened and the closing date has been extended until July 27, 2004, 2:00 P.M., Ft. Belvoir, Virginia Time (Eastern Standard Time).
2. Clause B34.01, SERVICES TO BE FURNISHED AND PRICES (DESC FEB 1991) paragraph C-1 has been revised to read: The following terms and conditions are applicable to obtain the necessary services and facilities to receive, store, and ship U.S. Government-owned petroleum. Any offeror must be able to provide fuel to at least one pier that can accommodate U.S. Navy oilers in that port. The storage facility must provide fuel storage facilities for F76 and JP5 at the port of Jebel Ali, United Arab Emirates (UAE) for the period of performance beginning October 1, 2004.
3. Clause B34.01, SERVICES TO BE FURNISHED AND PRICES (DESC FEB 1991) paragraph C-1.1 has been revised to read: **"Area of Consideration is defined as the Port of Jebel Ali"** in lieu of the 50 miles radius of UAE.
4. Clause B34.01, SERVICES TO BE FURNISHED AND PRICES (DESC FEB 1991) paragraph C-1.2 **Storage Tank Requirements** has been revised as follows:

C-1.2 **Storage Tank Requirements**: Approximately 1,967,874 barrels (fill capacity) of storage:

- (1) A minimum of 985,611 barrels of F76 (useable storage (defined as unobtainable plus useable inventory)),
- (2) A minimum of 982,263 barrels of JP5 (useable storage (defined as unobtainable plus useable inventory)).

A minimum of two tanks per product, interconnected and isolated from other facilities and products handled within the tank farm is desired, however, one tank per product will be considered. *Dedicated facilities are required.*

5. Clause E36, INSPECTION (STORAGE) (DESC FEB 1970), the services performed or facilities provided prior to **April 1, 2004** is hereby replaced to read: **"October 1, 2004"**.
6. Clause F76, CONTRACT PERIOD/PERFORMANCE REQUIREMENTS (STORAGE) (DESC DEC 1991), is hereby replaced to read: **"October 1, 2004 through September 30, 2009"**.
7. All other terms and conditions remains unchanged and in full force.
