SUBJECT: Policy on Funding of Filters for Fixed-Place Filtration Vessels, Revision 3

This policy letter supplements DESC Policy Letter dated September 29, 2001, DESC Revision 1 dated November 2, 2001 and DESC revision 2 dated May 6, 2002. Requests for additional National Stock Numbers can be made by submitting requests to DESC-BQ, Suite 2954, 8725 John J. Kingman Rd., Ft. Belvoir, VA 22015. Each request shall provide the NSN being requested to be placed on the approved list, the nomenclature of the requested item, Commercial and/or military specification, manufacturers name/part number/catalogue number, and type of filter vessel that the NSN is used in.

Revision 1 and 2 incorporates additional NSNs not incorporated into the attachment of the basic policy letter.

b. For elements purchased locally using a base's IMPAC card: Request your servicing DFAS Center or OPLOC to send an OPAC transaction using Bill to ALC 00006355 or a SF1080 billing document to DFAS-COLUMBUS along with a copy of the receipt document. DFAS-COLUMBUS will reimburse you using DESC funds. The billing transaction/document must state "FUEL FILTER ELEMENTS - ADVICE OF OBLIGATIONAL AUTHORITY NO. RB01033."

c. For locally written contracts: You may submit your funding request to either DESC-B or DESC-RB and a DIRECT CITE MIPR will be issued to cover the funding. A copy of the contract is required to be mailed to DFAS-COLUMBUS, and DFAS-COLUMBUS is required to be cited in the contract as the payment office for the Contract Line Item (CLIN) for the filter elements.
